6. **Formal Collection:** Will be taken if accounts are subject to collection if not paid within 90 days of the invoice date.

3. Finance/service charge on past due and unpaid balances shall accrue at the rate of 1 ½% per month, and the undersigned agrees to pay all finance/service charges on past due amounts.
4. The terms of this agreement are contractual and not merely recitals, and are intended to bind the heirs, executors, administrators, successors, and assigns of the applicant.
5. In the event that legal proceedings are instituted by Swiss Meat and Sausage Company pursuant to the collection of the said debt owed, the undersigned agrees and stipulates to the venue of the said proceedings to Gasconade County, State of Missouri.
